I expect, and will grade accordingly, that you will comply with the following:

- Essays will be single-spaced with normal default spacing, 1" margins, and of required length or the handwritten equivalent. You will use a font with a size of 11 or 12 and a face such as Times New Roman or the equivalent. Examples of faces you will not use are courier new and 0 CR. Failure to use an appropriate font can cost a 0.5 cut on each essay. Excessively short essays can cost a 0.5 cut for each such essay.
- 2) If the requirement is for a "short essay," such an essay will closer in length to a $\frac{1}{2}$ page than not.
- 3) Each essay will begin with a topic sentence or a thesis statement. *Failure to do this will cost* 0.25 each essay.
- 4) Remember the need to give credit where credit is due. Look again at the syllabus section on citing sources and plagiarism. When you draw from a reading or another source, credit the reading or source with a note in the form (Bressler, p. 180). *If I find generally inadequate sourcing, see citations in the syllabus*.
- You may collaborate, in accordance with the syllabus, on essays marked with a ◆. In this exam, these are the essays at 22, 38 & 41. For all other tasks, you may not collaborate. You may, however, use another student's class notes (not exam notes), but this must be done without reference to a specific question. In other words, you cannot just say something like: "Let me see your notes pertaining to question 32." If you collaborate on a marked question or use material gained from another student, credit that student with a footnote in the form (Sarah Smith).

Information communication technology (ICT) has become the foundation—both the one marrow and connective tissue—of modern societal economic growth and military power projection. As a result, cyberspace has emerged as a tool, target, and source of conflict for states and non-state actors. Cyberspace has blurred the lines between traditional conflict and peace, and states and private sector organizations are finding themselves in a state of protracted, low-level conflict in cyberspace. While conflict often takes the form of low-level acts of cybercrime or espionage, the specter of large-scale cyber conflict continues to rise. The nascent field of cyber intelligence—assessing an adversary's capabilities, intentions, and activities in cyberspace—is meant to provide clear, unbiased, and actionable information to an organization (public or private) to support and inform the entirety of an organization's network operations, including offensive and defensive processes. Elements of this field are cybersecurity and cyberwarfare, which depend upon cyber threats, cyber threat actors, and mechanisms for increased cyber resiliency in the public and private sectors.
